Whereas, Clifford C. Hay served as a member of the SUNY Cobleskill College Council from July 1, 2007 – April 8, 2016; and



Whereas Virginia Lee Kintz served as a member of the SUNY Cobleskill College Council from July 11, 2008 – June 30, 2015; and


Whereas, she was involved in the issues involving the council and was a positive representative of the council and the college in the community; and







Whereas, Thomas W. Greenlees, M.D. served as a member of the SUNY Cobleskill College Council from July 1, 1997 to February 18, 2013; and


Whereas he was always an active and productive participant in all discussions and issues involving the council; was always a positive representative of the council and the college in the community; and

Whereas, he will compete in Las Vegas in July, 2013 as one of the four regional winners for the American Culinary Federation's annual Chef Educator of the Year Award; and



Subject: Resolution – Approval of construction of a 156-bed Apartment-style Residence Hall

Whereas section 356 of the NYS Education Law authorizes the College Council to review and make recommendations with respect to “major plans” of the president of the College; and

Whereas by Resolution dated January 11, 2011, the SUNY Board of Trustees passed a resolution defining “major plans” to include, among other things, the construction of a student residential facility; and

Whereas, Officer in Charge Candace S. Vancko, has requested that the College Council approve plans for the construction of a 156-bed apartment-style residence hall located on Schoharie Parkway North, opposite the lower equine barn; and

Whereas, the College Council recognizes that an apartment-style residence hall will significantly enhance the College’s housing program and serve to attract and retain upper division students; now therefore, be it

Resolved, that the College Council approves the plan for the construction of the new residence hall contingent upon the receipt by the College of all the necessary approvals and financing for the project.

Background:

SUNY Cobleskill proposes to build a new 156-bed apartment-style residence hall. This proposal comes as a result of a 2008 master plan study by JMZ Architects and Planner, P.C., which recommended that the College construct such a facility to improve the housing offered to students on campus. A feasibility study conducted by MGT of America, Inc. demonstrated that in order for the College to remain competitive in attracting and retaining upper division students, it must build a residence hall facility of this type.

Pursuant to section 355(2)(i) of the NYS Education Law, the College is permitted to lease a portion of its real property to the Alumni Association of the State University of New York College of Agriculture and Technology at Cobleskill, New York, Inc. (Alumni Association) for purposes of constructing a new residence hall facility. The College proposes to work with the Alumni Association to construct the facility. Once constructed, the College will enter into a management contract with the Alumni Association (through a wholly-owned student housing corporation, a not-for-profit real estate housing corporation) to manage and maintain the facility. Under this proposal, tax-exempt financing will be sought through the Schoharie County Industrial Development Authority.
